BRNA Any dealer or their agent offering counterfeit, copies, or altered numismatic items as authentic will be subject to expulsion from the bourse without recourse or refund of fees or rental costs. Tables shall revert back to BRNA when the principal dealer ceases to setup at the Convention. Any dealers that have shared the table with the principal dealer is not entitled to that table. No early bird badge holder is allowed to be sitting behind a dealer's table.

Any dealer attending the show without his or her nametags will be asked to leave the show.

Note: Regular Dealers who pay a \$100.00 deposit or full payment during the 2018 convention will be assigned their table for 2019. No Guarantee of table location can be made or assumed without this deposit. Full payment must be received by May 1, 2019 to be assured the same table location. Temporary dealers will be given special consideration for next year's convention based on table availability. New dealer applications will be serviced as they are received and assigned a table on a space available basis.
